Rescuers on Sunday pulled a seven-month-old baby and a teenage girl from the rubble nearly a week after a powerful earthquake devastated huge areas of Turkey and Syria, killing more than 33,000 people.

UN relief chief Martin Griffiths warned that the death toll was likely to at least double, while denouncing a failure to provide sufficient aid for victims in war-torn northwestern Syria.

"We have so far failed the people in northwest Syria. They rightly feel abandoned. Looking for international help that hasn't arrived," Griffiths said on Twitter.

"My duty and our obligation is to correct this failure as fast as we can."

Griffiths arrived in southern Turkey on Saturday to assess the quake's damage, telling Sky News he expected the death toll to "double or more" as the chances of finding survivors dim with each passing day. Tens of thousands of rescue workers continued to scour flattened neighbourhoods in freezing weather that has deepened the misery of millions now in desperate need of aid.
